IDPH and the Executive Committee and Advisory Council are preparing a comprehensive State Plan that will be submitted to Office of the National Coordinator for Health IT (ONC) in order to release implementation funding available through the state grants to promote health information technology. This funding will be instrumental in developing a statewide health information exchange (HIE) infrastructure, which will enable the following core HIE services: continuity of care document, immunizations, labs, and e-prescribing. ONC identified five domains that must be addressed in the State Plan, which include: governance, finance, technical infrastructure, business and technical operations, and legal/policy. By linking those domains with our preliminary strategic plan, the Iowa Health Information Technology Plan, we will build upon existing planning efforts.

A physician practice assessment will be released in fall 2009 through a contract with Iowa State University. This assessment will capture provider baseline information including: current health information technology use and capabilities; preferences for types of high value clinical exchange; perceived benefits and barriers of health IT; and interest in receiving Medicare and Medicaid incentive payments. Information obtained from the assessment will be instrumental in finalizing the State Plan, which will include an implementation schedule for different provider types.

Medical Home System Advisory Council

The Medical Home System Advisory Council Progress Report #1 is available [here](#).

Iowa was recently chosen as one of eight states for the National Academy for State Health Policy (NASHP) Consortium to Advance Medical Homes for Medicaid and Children's Health Insurance Program (CHIP) Participants. Iowa's NASHP team attended the Consortium's kick-off learning session in Baltimore, Maryland in October 2009. To view the press release click [here](#).

Medicare will be joining Medicaid and private insurers in a new demonstration project to improve the way healthcare is delivered. The public and private payers will be based on a model of primary-care delivery that's currently being tested in Vermont. Under this model, private insurers work in cooperation with Medicaid to set uniform standards for advanced primary-care models (medical home). This demonstration marks the first time Medicare will participate as a full partner in these experiments, where the practice model would align compensation offered by all insurers to primary-care physicians. The Medical Home System Advisory Council has agreed to move forward to develop a plan for application. This is a 3 year demonstration project open to states.

The five overall goals of the demonstration are:

1. Reduction of unjustified variation in utilization and expenditure
2. Improvement in safety, timeliness, effectiveness, and efficiency
3. Increased patient participation in decision making
4. Increased access to evidence-based care in underserved areas
5. Contribute to 'bending the curve' in Medicare/Medicaid expenditures

Patient Autonomy in Health Care Decisions in Pilot Project Advisory Council (IPOST)

On November 6th, the IPOST Advisory Committee met to hear the progress and results of the Cedar Rapids Pilot Project and deliberate recommendations for the upcoming Legislative Session and the Governor. The local IPOST Committee recommended the extension of the pilot for another two years in order to more completely develop their community model and they recommended expanding the pilot into an adjacent rural community to more completely learn about the strategies necessary to implement IPOST in that environment. After rich conversations and much deliberation the Advisory Council produced a set of four recommendations of their own:

The Iowa Department of Public Health shall assist the community pilot in the following education and outreach activities: 1) Continue education of pilot county providers and promote change in all involved facilities; 2) Develop a plan for statewide outreach and education about the pilot program; 3) Identify statewide stakeholders to increase their knowledge of the pilot program; and 4) Determine if additional stakeholders should be included in the pilot program.

1. Affiliate with organizations (including but not limited to local public health departments to establish partnerships and enhance funding opportunities for replication of the IPOST pilot.
2. Continue data analysis including pilot medical chart reviews. Expand analysis to include health care providers, patient, and family surveys. Analyze the need for extension into various health care settings (home/hospital/rural/urban) and continue the literature review and content analysis for current best practice.
3. In support of the ultimate goal of statewide implementation of IPOST: we recommend a two year extension of the pilot project. This extension could include an expansion to a contiguous rural county that has a referral relationship with the pilot county. Additionally, in preparation for statewide implementation, assess the feasibility for future expansion to a community-based setting and a county with a state owned tertiary care hospital.
4. Continue the current pilot for another two years. Additionally, charge the pilot with assisting to provide outreach education statewide to achieve culture change. Collect data on the need for IPOST in all settings and do a needs assessment exploring regional and/or statewide future expansion. Identify sustainability issues including funding.

The next steps for the Council include the development of the report to the Governor and Legislature due by January 2010. The development of this report has begun with a first draft expected by middle of December. Click [here](#) for information about IPOST.

This council has not met since last-month's Check-Up. The past several weeks have been especially demanding as the State of Iowa works to address significant budget shortfalls. These efforts have required necessary delays in some projects, including work on the strategic plan, as budgets have been reexamined and impact plans submitted and approved. At this time, IDPH is not offering a projection regarding completion and release date of the strategic plan; however, IDPH will meet the statutory deadline of January 2010. In our ongoing efforts to make meetings as productive as possible, we have canceled the November 20, 2009 meeting. This council will not meet in December.

Mental health issues were discussed at the September meeting, and it was noticed that this topic was greatly overlooked in the initial report. The Council feels that they need more education and information about mental health, therefore the December 4th meeting will consist of a panel of mental health experts to share important information and strategies to the Council. Also, at this meeting, the Chair of the Legislative Health Care Coverage Commission, Dr. David Carlyle, will give an overview of the Commission and ways to collaborate. The Direct Care Worker Advisory Council met on Thursday, November 12th. Guest speaker, Eileen Creager, Iowa Medicaid Enterprise, provided a presentation regarding Consumer Directed Attendant Care Services (CDAC) and Consumer Choice Option (CCO). Jennifer Furler reviewed progress toward compiling a list of research about return on investment of education and training. Shelly Chandler, representing the Iowa Association of Community Providers provided council members with copies of a letter addressed to Director Tom Newton. The letter stated the withdrawal of the Iowa Association of Community Providers and disability providers from the council. It formally requested that recommendations made by the council regarding the mandatory credentialing process not be applied to disability providers.

Youth Individual Challenge: The Council is partnering with the Live Healthy Iowa Kids program through the Iowa Sports Foundation. New tracking posters were designed to add the healthy behaviors fruit, vegetable, water & milk and limiting screen time to the current physical activity tracking system. The Live Healthy Iowa Kids/Iowa Governor's Youth Challenge will begin in January, 2010.

School Challenge: The Governor's Council has agreed to support the criteria of the USDA's HealthierUS School Challenge ([click here](#)) for the school award. They have developed 12 core strength training exercises, in instructional picture format, for use as a resource to develop the physical activity criteria of the challenge.
